This list includes microform texts, abstracts and indexes, and other government information sources acquired as collections or sets outside the Federal Depository Library Program (FDLP). Most were purchased from commercial publishers and vendors such as Lexis-Nexis™ Academic & Library Solutions™ (formerly CIS) and NewsBank™ (Readex). Electronic indexes and collections, such as the Lexis-Nexis Congressional Universe, are noted where appropriate. Since these resources are “owned” by the VIVA consortium, to which many Virginia depository libraries belong, VIVA is listed as the “owning” library for these electronic resources.

This Union List serves as a supplement to the Virginia State Plan for FDLP Libraries in Virginia. It is intended as a cooperative referral aid to assist depository librarians in Virginia in locating government information sources outside their own libraries. The owning library is solely responsible for determining rules governing the use of these materials.
